# Ynot's Blurb–November 2009

Hi all,

The rapid pace of our club's formation and operation has been remarkable. It was only yesterday that the idea was just a topic of discussion. Sarge has identified the progress we have made in his report, so I won't repeat it here. It just proves what can be achieved by a group of motivated people pulling in the same direction.

Your committee is hard at work at the moment building the foundations of what is shaping up to be a very dynamic and exciting club. We are currently finalising the requirements for incorporation. The Government Department— Fair Trading—has already responded to our application requesting a few minor adjustments to the rules of association, and these have been supplied, so we are awaiting their final approval.

Various committee members are writing the By-Laws that are necessary for the day-to-day running of the club. At our committee meeting the writing of the By-Laws was allocated as follows;

As each By-Law is developed by the committee, it will be revealed to the membership and included in the By-Law document that every member will have access to. It is intended that the By-Laws will be a living document, and may be changed to suit the changing requirements of the club. The process for change will be kept as simple as possible and can occur at a monthly meeting. The intention of having By-Laws is purely to enable the committee and members to clearly understand how the club operates, and to provide guidelines for action. They are not intended to be a restrictive control mechanism.

Whilst the roles of office bearers have not been finalised yet, it was decided at the committee meeting that the roles of Coordinator and Ride Captain needed to be clarified immediately because there was some confusion regarding these roles. I submitted proposed roles for these two positions, and they were accepted by the committee. The roles will be included in the relevant By-Law when it is published. In the interim period, if any member wants a copy they can contact me. They are also available on our web site.

The Event Calendar was discussed a length, and it was decided to have a rolling 12 month Event Calendar. This means that we will have a 12 month calendar of events that will be updated every 3 months. If any member has a suggestion for a ride, please give these to a Ride Captain to be considered for inclusion in the Event Calendar. If any member has a suggestion for a social event, please present it to the Coordinator for consideration for inclusion in the Event Calendar.

The finances of the club are being closely controlled by our treasurer, Kmac. There are lots of expenses associated with the start-up of a club such as this. So far we are just keeping out heads above water, and will have to rely heavily on the club raffles to fund our operations for the first year. So, dig deep into your pockets at raffle time and support your club. We are receiving numerous offers of donations for raffle prizes. Thank you to all concerned. This is another indication of the commitment of our members, and their desire to see the club succeed.

It is extremely important that all members understand that the club does not yet have public liability insurance. At all events we are all individually responsible for our actions, and we must always practice safe behaviour, and be conscious of the consequences of our actions. The Steel Horses Cruising Motorcycles Social Club is not in any way liable for any damage or injury in whatever form you may incur whilst attending a club event.

Sarge has developed some ride rules that will shortly be published. Each Ride Captain will be responsible for ensuring that these ride rules are explained to all riders at the start of and during each ride. Please listen carefully to the instructions issued by the Ride Captain and always follow their instructions. Having said this, you are ultimately responsible for your own safety, and you must always ride within your own skill and comfort zones, and the prevailing traffic conditions.

There are so many other issues that I could talk about, but I'm sure they will arise at future meetings and events. If you have something to discuss, please include your issue on the monthly meeting agenda, or discuss it with one of the Committee Members or Ride Captains. It is your club; get involved.

# Minutes of meeting—20 October 2009 @ Broadway Hotel

Meeting Opened:	7.06 pm by Ynot.
Attendance:	24 members attended. They were: Apples, Barney, Cougar, Debbil, Drastic, Gers, Gin- ger, Helen, Huffy, Jenny, Jewles, Kaz, Kmac, Loges, Phil, Popeye, Rowdy, Sam, Sarge (Steve Sargeant), Sparra, Steiny, Sugar, Ynot, and Yogi.
Visitors:	There was 1 visitor. This was: Jacki.
Apologies:	5 members sent apologies. They were: Boots, Cosmo, MG, Princess and Wingman.
Minutes of Previous Meeting:	As this was an inaugural meeting of the club there were no previous minutes.
Business arising from minutes:	Nil
Correspondence In: / Out:	Nil
1. Introduction:	<b>Sarge</b> (Steve Sargeant) introduced the club to everybody. He emphasised that it was a club for all members. He then explained that if the club became Incorporated, it would be a legal entity in its own right, and that the group involved in forming the club had decided to go down that path. He further explained that all members will have full access to all Rules and Bylaws, and that although he expected there to be differences in opinions in the course of time, all of those opinions will be respected and listened to.
2. Nominations for Management Committee	<ul> <li>Ynot called for nominations for positions on the management committee.</li> <li>Sarge nominated Ynot (Tony Lowe) for President, Debbil (Ian Nicholson) for Secretary, and Kmac (Kelvin McBride) for Treasurer. All 3 accepted.</li> <li>Debbil nominated Sarge (Steve Sargeant) for GM, and he accepted.</li> <li>Sparra nominated both Sugar and Kaz as joint Coordinators. After clarifying how this might operate, both accepted.</li> </ul>
3. Motion for Association name	<b>Debbil</b> moved that the club be called STEEL HORSES CRUISING MOTORCYCLES SOCIAL CLUB. Sparra seconded it: in favour 24, against 0. Motion was Carried.
4. Motion to incorporate the asso- ciation	<b>Ynot</b> moved that STEEL HORSES CRUISING MOTORCYCLES SOCIAL CLUB incorporate as an incorporated association under the provisions of the Associations Incorporation Act. Sarge seconded it: in favour 24, against 0. Motion was Carried.
5. Motion that the rules of the as- sociation be those distributed to members	<b>Ynot</b> moved that under the provisions of the Associations Incorporation Act, the rules of STEEL HORSES CRUISING MOTORCYCLES SOCIAL CLUB be those distributed to members. Steiny seconded it: in favour 24, against 0. Motion was Carried.
6. Motion to appoint a member to make application for incorpora- tion	<b>Ynot</b> moved that <b>Debbil</b> be appointed to make application for STEEL HORSES CRUISING MOTORCYCLES SOCIAL CLUB to be an incorporated association. Rowdy seconded it: in favour 24, against 0. Motion was Carried. Debbil said that it would take 5-12 weeks.
7. Election of members of the management committee	As chair, <b>Ynot</b> moved that all nominees for management committee positions be elected unopposed. Sparra seconded it: in favour 24, against 0. Motion was Carried. Therefore Sarge is GM, Ynot is President, Debbil is Secretary, Kmac is Treasurer, and Sugar and Kaz are joint Coordinators.
8. Fee structure and payment of fees	<b>Debbil</b> spoke about the fee structure. He said that annual membership would be \$3 a month for Riders, \$2 a month for Pillions, and \$1 a month for Social members. This to be paid annually. There would also be a joining fee to cover club costs. This was currently \$30 for Riders and Pillions, and \$20 for Social members. He also stressed that the joining fee would change as costs changed. Barney moved that this fee structure be accepted. Loges seconded it: in favour 24, against 0. Motion was Carried.

9. Appointment of Ride Captains	After some discussion, <b>Steiny</b> moved that the ride captains be Sarge for Central, Yogi for South, and Sam and Cosmo for West. Kmac seconded it: in favour 24, against 0. Motion was Carried. Yogi said sometimes he might have a problem with Saturday rides. Sparra spoke about the need for "backups" for the Ride captains.
10. Patches / Insignia	<ul> <li>Sarge modelled the club Patch and Handle/Name Insignia and Honorary Insignia, and their positioning. Ynot then moved that they be accepted as the official club regalia. Sparra seconded it: in favour 24, against 0. Motion was Carried.</li> <li>Ynot pointed out that the position of the "Original" honorary insignia had changed since the newsletter was distributed, and that "Original" would only go to members who joined before the December meeting. He said that the Management Committee would consider the need for "date" insignia after that.</li> </ul>
Other Business (without notice):	<ul> <li>Debbil stated that a Rider's Choice would be included in the Event Calendar for most months. He explained what they were and how they worked.</li> <li>Cougar moved that the Xmas party on Saturday, 5 December be held at Sarge &amp; Sugar's residence this year and that a more formal venue be used in 2010. Motion was Carried.</li> <li>Ynot explained that visitors could attend social events provided they paid their way.</li> <li>Debbil spoke about the need for the club to have a web presence, and it would therefore need a domain name and web host. He estimated costs at an approximate total of \$230 a year.</li> <li>Debbil moved that this expense be authorised. Ynot seconded it: in favour 24, against 0.</li> </ul>
	Motion was Carried. <b>Ynot</b> explained that Loges had offered to service the club's need for promotional material. <b>Jewles</b> moved that a Business register amongst members be created. Yogi seconded it: in favour 24, against 0. Motion was Carried. Ynot then "volunteered" Jewles to do this. <b>Huffy</b> asked if it would be OK to donate drinks to the Xmas party. She received a positive

# **By-Laws—Ride Rules**

#### **"SAFETY OVERIDES ALL RULES"**

- 1. All members should contact the Ride Captain the day before a ride to advise they would be attending.
- 2. All riders must meet at the appointed meeting area at least 10 minutes before the specified departure time with a full tank of fuel.
- 3. The Ride Captain is the only person who will alter the destination on a given ride day.
- 4. All members must comply with the Ride Captain's instructions concerning safety or behaviour.
- 5. Position yourself in the front, middle or back of a ride where you feel the most comfortable.
  - Try not to keep changing positions.
  - Ride in a staggered formation.

- Try to keep the group together, as long as you are not exceeding your level of skill and comfort.
- However, always put your personal safety above any other consideration such as ride formation or meeting point times.
- 6. Always keep the rider behind you in view whenever possible.
  - If you lose sight of following riders, pull over in a safe but visible position.
  - The designated "Tail End Charlie" must always remain at the back of the ride.
- 8. The Ride Captain must not leave the ride without nominating a backup ride leader, and ensuring that everyone is aware of the substitution.
- 9. Never pass the Ride Captain unless you have their specific permission to do so.
- 10. Riders may leave the ride on a nominated "breakout" that the Ride Captain will indicate by waving their left arm over their head.
  - If you pass the ride captain on a breakout you have formally left the club ride, and may rejoin the group later.
- 11. When overtaking a vehicle, riders must ensure that they do so safely, and allow sufficient room for following riders.
- 12. If you have any issues with the conduct of the ride, make sure you discuss these with the Ride Captain at the first opportunity, and if possible before the ride commences.
- 13. Always wear your vest to Club rides.
- 14. Always remember you are on this ride for the primary purpose of having fun and a good time, so enjoy the ride and join in all the activities on the day.

You are? That's because these files have been saved by Microsoft Office 2007 programs.

To read them, go to http://www.microsoft.com/downloads/en/default.aspx and find the "Microsoft Office Compatibility Pack for Word, Excel, and PowerPoint 2007 File Formats".

Then download the file "FileFormatConverters.exe". When you run this program it will add file converters to your WORD, EXCEL and POWERPOINT programs. They will then automatically open those previously unreadable attachments for you.

If all that fails, contact the Secretary, who will send you a copy of the file.

# Ride—Saturday, 10 October 2009—UMC ride

I arrived at Maccas Goodna about 8 am and as no one was waiting I decided to go and have a look for the UMC Qld ride meeting point that was supposed to be the Redbank Plans Pub.

I had never been to this Pub before so I was applying the 5P rule (Prior Preparation Prevents Piss Poor Performance).

I knew the general direction so headed back through the underpass to the other side of Ipswich Road and turned left at the lights. This took me along the service road for about a Kilometre until it ran out and by this time I had worked out that I was going in the wrong direction. A quick check of my mirrors and a legal turn was performed. Just as this was completed I was greeted by Blue and White flashing lights and a siren wail from the Red Mitsubishi sedan that had been following me. Being a law-abiding rider I immediately pulled over and stepped off the Bike followed by the Red police car.
